Equipment

In aChord Sound Minimum Equipment Requirements:

- Piano (if on site Purchaser will assure it is tuned prior to performance)
- 5 Microphones w/ stands – 4 for group, 1 solo (solo wireless preferred but not mandatory)
- Floor Monitor(s) (at least 1) for group and 1 monitor for accompanist
- Speaker System ample for venue requirements
- Ample Power outlets to stage area.
- Cleaned Stage Setting – minimum size needed 11' X 8' (for vocal performers excluding accompanist or other musicians)

If sound equipment is available for use at the venue a sound technician familiar with the equipment should be available to discuss plans for use and requirements for performance at the time of the venue review.

NOTE: Purchaser agrees to additional cost of technician if necessary for use of their equipment or fee for use of In aChord sound technician.

Artist will provide sound equipment and electric Piano if Purchaser's sound equipment does not fit the needs of the Artist after the venue review is completed. Base fee is \$100 for equipment and technician.

Note: If In aChord's basic sound system does not meet the needs for sound amplification at the venue a review of additional equipment needed will be discussed and cost for necessary additional rental sound equipment will be paid for by the purchaser.

An equipment review will be part of the details of the venue visit and a final checklist of equipment provided by both purchaser and artist will be completed and signed at that time.

Equipment Delivery and Setup

Delivery, setup, and storage of necessary sound equipment to be worked out in advance by the Purchaser and Artist after the site review.

Sound Check

Ample time for setup and technical sound check is mandatory; exact time to be mutually arranged between Purchaser and Artist. Generally at least 2 hours prior to show time at least is preferred.

Parking

To be determined during venue visit and review as agreed upon between Purchaser and Artist

Security

Purchaser agrees to guarantee proper security at all times to ensure the personal safety of the Artist, auxiliary personnel, equipment and personal property, during and after the performance.

Liability

Neither Artist nor Purchaser will be liable for failure to perform under this agreement where forces beyond the control of Artist or Purchaser cause the failure, as the case may be. Such forces include without limitation, government actions, illness or disability of Artist, and acts of God including severe weather or natural disasters.

Artist does have liability insurance documentation available if requested by Purchaser
